




# Cynthia Samuel-Olonjuwon

Assistant Director-General, Regional Director for Africa, International Labour Organization (ILO)

Cynthia Samuel-Olonjuwon is the Assistant Director-General and Regional Director for Africa of the ILO. Prior to her appointment to this position, Ms Samuel-Olonjuwon was the Deputy Regional Director for Africa. She joined the ILO in 1995, where she has held different positions in Headquarters in Geneva and the field, including Chief of the ILO Programming Unit for Africa. She has more than 33 years' experience of dedicated and passionate service to promote: decent work for women and men, gender equality, youth employment, SME development, elimination of child labour and enhanced labour migration. She served along with the AFDB President, on the High-level Panel on Migration chaired by President Sirleaf Johnson. Ms Samuel-Olonjuwon was identified by the African Rating Firm, Avance Media, as one of the 100 Most Influential African Women in 2019. She is also a strong advocate for women's rights. Ms. Samuel-Olonjuwon was on the Board of the International Sociological Association (Research Committee on Women in Society) from 1986 to 1990.

# Professor and DST/NRF SARChI Chair in Social Policy at the College of Graduate Studies, University of South Africa

Educated at the University of Ibadan (Nigeria) and Warwick University (UK), Prof Adesina taught at the University of Ibadan (Nigeria), was Professor of Sociology at Rhodes University (South Africa), and Professor and Head of Department at the University of the Western Cape (South Africa). He has held visiting appointments at Ulster University, Derry (Northern Ireland), University of the Witwatersrand (South Africa), Oxford University (UK), Nordic Africa Institute, Uppsala University (Sweden), UNECA (Addis Ababa), and the UN Research Institute for Social Development (Geneva). A past President of the South Africa Sociological Association (2004-2006), Professor Adesina was elected to the Academy of Science of South Africa (ASSAf) in 2005. He serves on the Board of the UN Research Institute for Social Development (Geneva) and the Board of RC19 of the International Sociological Association. His research interests include Sociology, Social Policy, and the Political Economy of Africa's Development. He has published widely in these areas.
